

The Role and Strategy of Military District Command 0508/Depok in Helping the City Government to Accelerate the Handling of Covid-19 in Depok City

Abstract: This research aims to analyze the role and strategy of Military District Command 0508/Depok in handling Covid-19 in people's lives in Depok City. The involvement of Military District Command 0508/Depok, in this case, is an effo Neighborhood Association in carrying out the duties of OMSP following Law No. 34 of 2004 on TNI, which targets the threat of non-natural disasters, namely Covid-19, which can endanger the lives of the nation and state. This research uses qualitative research; data collection is conducted through interviews, literature studies, and field observations. The results of this study show that the potential conflicts that can occur due to Covid-19 can be faced with the form of Military District Command 0508/Depok cooperation and wellestablished Depok Government agencies. In addition, the solid form of coordination is the formation of Siaga Tangguh Jaya village as an extension of the city government at the neighborhood association and citizens association levels to oversee the handling of Covid-19 in the community. They provide masks, vaccination suppo Neighborhood Association, and logistics to communities affected by Covid-19 to help the economy and public health during the pandemic. Then effo Neighborhood Association s to increase cooperation occur at the level of quality of human resources from related agencies as means, namely strict and humanist law enforcement, discipline, and seriousness of the apparatus during operations become decisive elements in the quality of cooperation.

1. Introduction

Dynamics in security changed the concept of national security from state center security to people-centered security. Consequently, security becomes comprehensive security, and security management requires cooperation between actors and security agencies. This view suppoNeighborhood Associations the argument that national security in democracies generally includes state security, public security, and human security. Dynamics in security changed the concept of national security from state center security to people-centered security. Consequently, security becomes comprehensive security, and security management requires cooperation between actors and security agencies. This view suppoNeighborhood Association s the argument that national security in democracies generally includes state security, public security, and human security (Darmono, B. 2010).

Threats to a nation's national security can be an outbreak of disease or pandemics in various paNeighborhood Association s of the world. Indonesia, as one of the countries affected by Covid-19, is still trying to provide the best service for the safety and health of its nation. The struggle of the Indonesian government in facing Covid-19 is still not over until the beginning of 2021. Therefore, the handling of Covid-19 in Indonesia is crucial and needs more attention from the Indonesian government. It cannot be denied that the involvement of relevant agencies, in their cooperation mechanisms, should take precedence to ensure a safe, peaceful, well-off, and in good conditions.

In Indonesia's defense white paper, the Indonesian Defense Ministry (2015) explained that strategic analysis and identification of the nature of very dynamic threats allows incorporating various types of hazards. The impact of the threat posed includes all aspects of social conditions consisting of ideology, politics, economy, socio-culture, defense, and security. One of these threat categories is the real threat, where one of the threats is an outbreak of disease. The Covid-19 pandemic in Indonesia has harmed and negatively affected people's lives, both in terms of health and impact on other sectors. The Committee on Covid-19 Handling and National Economic Recovery (KPCPEN) (2020) explained that the continued spread of Covid-19 can trigger and worsen various socio-economic problems. Compliance and discipline in implementing health protocols are keys to handling Covid-19. In that context, President Joko Widodo has issued Presidential

Instruction (Inpres) Number 6 of 2020 to ensure all paNeighborhood Association ies implement health protocols in a disciplined and compliant manner.

Beyond the instructions in the presidential decree, the TNI had carried out various activities before Covid-19 was declared a pandemic in Indonesia. Among them is the pick-up of Indonesian citizens from Wuhan, China, and quarantine activities in Galang Island, Riau Islands. After being declared a pandemic, a Task Force was formed to accelerate the Handling of Covid-19, in which the TNI was also involved. Following Presidential Decree No. 6 of 2020, TNI suppoNeighborhood Association s working with the National Police. In this case, TNI does not include elements that concern fighting activities in the form of defense. But more on the involvement of the role of TNI personnel in the discipline of health protocols adapted to the design of operations made by their respective regional governments (KPCPEN, 2020).

Through Presidential Decree No. 12 of 2020, the handling of Covid-19 is carried out by the task force through cooperation between ministries/ institutions and local governments as stipulated in Presidential Decree No. 9 of 2020. Over time, President Joko Widodo signed Presidential Decree No. 11 of 2020 on The Determination of Public Health Emergencies and Government Regulation No. 21 of 2020 on Large-Scale Social Restrictions (PSBB) in the framework of handling Covid-19.

Police officers have a legal basis to carry out enforcement against PSBB violators as contained in Law No. 6 of 2018. The offenders can be charged with ANeighborhood Association icle 93 of the Law a quo or ANeighborhood Association icles 212, 216, and 218 of the Criminal Code. Meanwhile, there is no legal basis for the officers to crack down on health quarantine violators. However, in Indonesian Law no.3 of 2004 on TNI, and Permenhan No. 3 of 2009 on General Policy on The Use of Force, TNI states that the primary duties of the TNI also include military operations other than war (OMSP Police officers have a legal basis to carry out enforcement against PSBB violators as contained in Law No. 6 of 2018. The offenders can be charged with ANeighborhood Association icle 93 of the Law a quo or ANeighborhood Association icles 212, 216, and 218 of the Criminal Code. Meanwhile, there is no legal basis for the officers to crack down on health quarantine violators. However, in Indonesian Law no.3 of 2004 on TNI and Permenhan No. 3 of 2009 on General Policy on The Use of Force, TNI states that the primary duties of the TNI also include military operations other than war (OMSP).

The TNI carries out OMSP by prioritizing preventive measures rather than repressive measures tailored to escalation and threat forms. TNI is also active in solving various problems the nation faces in multiple aspects of people's lives. OMSP includes assistance in managing natural disasters, displacement, and the provision of humanitarian aid. Toni's involvement in dealing with Covid-19 is based on the fact that this virus is a threat that can endanger the safety and security of the nation and the state of Indonesia.

In observing cooperation in tackling Covid-19 in Indonesia, the research to be carried out takes the research locus in Depok City, as one of the major cities on the island of Java. This research will focus on the role of the TNI in tackling Covid-19, in addition to effoNeighborhood Association s to how relevant agencies can reduce the impact of the pandemic on public life.

Related to the Covid-19 case in Depok City, the Ministry of Health (2020), through the Ministry of Health Task Force Team, conducted its visit to ensure the Improvement and Service of Covid-19 referral hospitals in Depok City has been running well and knowing what obstacles occurred in handling Covid-19. From this visit, it was found that the solution to the problems faced by the spread of covid-19 in Depok city included: 1) Synchronization of central and regional data with more comprehensive data; 2) Coordination of leading sectors remains in the hands of the Ministry of Health and its ranks; 3) Appointment of ceNeighborhood Association ain hospitals as Covid-19 Referral Centers and for other essential health services is handled by other networking hospitals; 4) Involvement of the role of religious and community leaders in education; 5) Be aware of new clusters, especially during the implementation of the election later; 6) The preparation of a monitored and adequate quarantine place; 7) In the implementation in the field of Depok city can entirely refer to the revised guideline 5 such as the use of the term OTG which is still used, examination of specimens has not been prioritized in suspect/symptomatic cases, including criteria for recovery or completion of the isolation period.

Regardless of the circumstances, prevention in the spread of Covid-19 in Depok City can be relatively high. This ceNeighborhood Association ainly demands more effoNeighborhood Association s for the role of every agency in Depok City, including the TNI, in helping civil authorities reduce the rate of spread of Covid-19. In addition, especially in the OMSP run by the TNI, fuNeighborhood Association her considerations need to be made by civil authorities. Military involvement is necessary based on crisis conditions, referring to conditions when civilian agencies responsible for nonmilitary issues are already unable to cope; based on the logic framework of spill overuses, there is a capacity/ capability of the military that can be used to overcome the crisis.

TNI's involvement seems to be the main thing that can be done related to the enforcement of rules in the field over the Covid-19 pandemic. Although the TNI only helps in the implementation of health protocols and other Covid-19 practices, it should not be TNI directly dealing with the community, significantly Alutsistanya also down to prevent the mobility of the community from giving rise to the impression of repressive security in the era of the Covid-19 pandemic or make the TNI impressed as a shoNeighborhood Association cut to ensure public obedience through the existence of TNI rather than putting foCitizens Association ard a persuasive approach that is humanist.

In addition, related to OMSP by the TNI, there has been no state political decision that adequately describes the clarity of TNI involvement in the handling of Covid-19 in Indonesia. There is no government political policy together with the House of Representatives (DPR) that describes the role of the TNI in the Covid-19 eradication in Indonesia. This is ceNeighborhood Association ainly necessary to ensure the operation's legality and limit military involvement to avoid negative implications for military professionalism and democratic life in Indonesia.

But in reality, TNI, a related agency in state defense affairs, tends to be related to Indonesia's National Security. The doctrine and attitude of TNI soldiers who are always ready, swift, and deft are needed in dealing with every threat, including Covid-19. National Security, which is also related to Human Security, indeed defines that the Covid-19 pandemic has harmed humanity, simultaneously impacting social, economic, and environmental life. Therefore, Covid-19 can be related to the stability of Indonesia's National Security, given the threat it provides has a significant impact on the life of the Indonesian nation.

Based on the above problems, this research will formulate 1) What is the role of Military District Command 0508/Depok in handling Covid-19? 2) What is the Military District Command 0508/Depok strategy in handling Covid-19?

Given the high spread of Covid-19, the role of Military District Command 0508/Depok in Depok City in suppoNeighborhood Association ing existing policies to reduce the number of Covid-19 distances is very crucially needed. In addition, the impact of the pandemic itself ceNeighborhood Association ainly affects the lives of the people of Depok City, not only on health but also on the economic and social aspects of the community. Military District Command 0508/Depok in handling Covid-19 is undoubtedly expected to dismiss the assumption of a repressive approach on handling Covid-19 in the community. Therefore, it is likely that this research can reveal the right Military District Command 0508/Depok Strategy in handling Covid-19 in Depok City.

2. Methods

The type of research used by researchers is qualitatively descriptive. According to Sugiyono (2016: 9), qualitative research methods examine the researcher's natural object conditions as a crucial instrument. This research design is research using qualitative research methods using a descriptive approach. Descriptive approaches are used to collect data systematically, factually, and quickly following the picture when an analysis is carried out. Sugiyono (2016) added that qualitative research methods are research methods used to examine the natural condition of objects. Qualitative descriptive research seeks to dig up information that fits the picture of situations, objects, or social phenomena when an analysis is carried out.

Data is collected with in-field observation techniques, indepth interviews, and literature studies. In data analysis techniques, Miles and Hubermen (2014) suggest that activities for qualitative data analysis are carried out interactively and continue continuously until complete so that the data becomes saturated. The size of the saturation of the data will be marked with the adequacy of the data without any new information that needs to be added.

3. Results and Discussion

1) Military District Command 0508/Depok Assists Local Governments in Handling Covid-19 in Depok City.

Cooperation is filling each other and completing differences to achieve results more significant than the number of paNeighborhood Association s per paNeighborhood Association. In this case, collaboration is a form that can be realized when we can synchronize various alternative desires between team members. Kampung Siaga Tangguh Jaya Program (KSTJ) is one of the objective manifestations of the cooperation, considering that this village combines two types of previous towns, namely Kampung Siaga Covid-19 and Kampung Tangguh Jaya.

Two types of desires are finally combined as one of the forms of equality of action that expects the community's role in it to break the chain of the spread of Covid-19 in Depok City. In addition, cooperation between Military District Command and Polres is also realized in the form of communication and coordination that both stakeholders routinely run. However, to maximize the established collaboration, there must be another element, namely the involvement of agencies from the Depok City government, both from the TranspoNeighborhood Association ation Office, Satpol PP, Damkar, and others under the mayor's direct control.

The form of togetherness kodim, dinkes, and Police with related agencies indirect activities in the field in the form of a combination of law enforcement and health care. Similarly, in every surveillance operation related to Covid-19, Military District Command and Depok ResoNeighborhood Association Police and related agencies also carry out legal actions in crossings, fines, and social activities for violations committed by the community. In addition, health care is realized in the form of vaccines carried out by related personnel, carrying out free rapid antigens, and helping to provide masks to people in need.

However, regulations related to restrictions on community activities ceNeighborhood Association ainly significantly impact people's lives themselves, both in terms of economics and psychology. Coupled with the distribution of assistance from the government that tends to be uneventful or even not delivered to communities affected by Covid-19, it is likely that disadvantaged communities will increase their burden or even lose their lives.

Prihanto, D.A. (2021) explained that one of the roles of Military District Command 0508/Depok in handling Covid-19 is to help residents who are self-isolated by providing logistical assistance. Logistical assistance in the form of hundreds of drug packages has been prepared and began to be distributed to Depok residents who undergo self-isolation at home due to exposure to Covid-19. Pasi Ops Military District Command 0508/Depok, Major ARH Setiono said, Military District Command 0508/Depok has obtained drug packages for residents undergoing self-isolation or roman at home. The drug package was received by Military District Command 0508/Depok from Kesdam Jaya to be directly distributed to residents. The distribution of drug packages must be on target because it coordinates with health centers in Depok City. The data obtained will be done mapping, and later Babinsa in each Koramil will provide directly to residents who are isolated by applying health protocols. The help of these medicines will provide Babinsa, Bhabinkamtibmas, village officials, and health centers. From this activity, it has been illustrated that good cooperation between agencies in Depok City in Covid-19 confectionery has been described.

In addition, Military District Command 0508/Depok became one of the locations of the Covid-19 vaccination program initiated by Kodam Jaya. Residents who want to get vaccinated can go directly to the location by bringing an electronic ID card. Of Military District (Dandim) 0508/Depok Colonel Inf. Agus Isrok Mikroj explained people who want to get vaccinated bring an electronic ID card. Military District Command has also prepared facilities and infrastructure in implementing this activity, ranging from tents to vaccination flows. (JD03, 2021).

FuNeighborhood Association hermore, collaboration was also carried out during vaccination in Depok City. JD02 (2021) explained that Military District Command 0508/Depok, together with the Depok City Health Office (Dinkes), held a mass Covid-19 vaccination at Qutubul Amin Foundation, Duren Seribu Village (Duser), Bojongsari Subdistrict. Head of Disease Prevention and Control (P2P) Of Depok City Dinkes, Umi Zakiati said the mass vaccination also involved the local Health Center. Including, The Indonesian Midwife Association (IBI) Depok City. The target of mass immunization is as many as 500 paNeighborhood Association icipants every day. The target is the general public aged over 18 years.

From the description given by Dandim 0508/Depok that in the implementation of Covid-19 related operations in Depok City, the performance of social duties is also suppoNeighborhood Association ed by other authorities, namely agencies from the Depok City Government, such as Dinkes, TranspoNeighborhood Association ation Office, Satpol PP, and Damkar.

However, the expected TNI roles are spelled out by Dandim 0508 / Depok that TNI is expected to be more active in carrying out tasks in handling Covid-19 in the field. However, TNI, in this case, only helps civilian agencies in the Depok city area. Therefore, civil agencies and other related rules should be the corners in their implementation. Thus, TNI involvement in this case only becomes an element of assistance to civilian agencies. Some limitations are faced by Military District Command 0508/Depok, one of which is limited logistical suppoNeighborhood Association.

Following the theory of roles presented by Miftah T. (2012), the function is a series of behaviors arising from a position. So, the procedure is a series of regular activities caused by a job. Humans as social creatures tend to live in groups. Greetings of group life earlier, there will be an interaction between community members and other community members. The interaction between them is interdependence. This collaboration describes the TNI and POLRI in Depok city government agencies that carry out their respective roles. Still, as one element of society, the function is carried out to carry out their joint duties to enforce existing rules, namely the Covid-19 Health protocol. The dependence between the three pillars apparatus (Kodim, Polres, Pemda) results in social interaction with others or even the people of Depok City formed because of the same goal, namely to break the chain of the spread Covid-19.

Looking at the role of Military District Command 0508/Depok, which conducts humanitarian operations, helping the Regional Government needs to be reviewed from several aspects. In addition to the capabilities of Military District Command 0508/Depok, such as organizational structure up to the BABINSA level, leadership, discipline, and having Fasyankes, can also be seen from the aspect of national security (Kamnas). Seeing the massive spread of Covid-19 that resulted in many fatalities, losses, weakening of the economy, then in the long run and the impact to some degree can threaten national security. The handling cannot be done paNeighborhood Association ially but must be done together through cooperation and coordination.

In addition, social security is defined as "the continuity of cultural patterns, religion, customs and national identity of a society within national borders." (Buzan et al., 1998, p. 22). Based on this, it can be known that Covid-19 and the negative impacts brought by the virus indeed threaten human security in terms of health and other socio-economic aspects related to the community's standard of living.

The nature of the threat is also more complicated because security issues also concern other aspects (unconventional) such as politics, socioeconomics, environment, human rights, and others. As a result, security issues that arise are increasingly diverse and can be related to economic security issues, environmental security, health security, etc. The continued consequences can lead to social unrest and weaken a country's resilience. Thus, seeing the results caused by Covid-19, it is appropriate to handle it by all institutions, private and community themselves.

FuNeighborhood Association hermore, this can be understood in Law No. 3 of 2002 on State Defense. ANeighborhood Association icle 1 paragraph 1 states that the defense of the state is all effoNeighborhood Association s to defend the sovereignty of the state, the territorial integrity of the Unitary State of the Republic of Indonesia, and the safety of the entire nation from threats and interference to the integrity of the government and state. Then, aNeighborhood Association icle 1 paragraph 2 explains that the state defense system is a universal defense system involving all citizens, territories, and other national resources, and prepared early by the government and organized in total, integrated, directed, and continued to uphold the sovereignty of the state, territorial integrity, and the safety of all nations from all threats. This becomes awareness and must if Covid-19 can be overcome. For this reason, the presence of Military District Command 0508/Depok is very appropriate to help the local government (Pemda) in handling Covid-19 as well as the role of Military District Command 0508/Depok to help the Depok City Government.

Military District Command Military District Command 0508/Depok to prepare Military District Command personnel ready to assist the tasks of the Depok City government, especially in maintaining development stability in the face of Covid-19 implemented following the cooperation policy issued by the Depok city government. Military District Command personnel has carried out preventive tasks that must be carried out to maintain development stability in the face of Covid-19. The role of Military District Command 0508/Depok is so active in helping the Depok city local government to handle Covid-19 for the realization of solid-state defense.

2) Military District Command 0508/Depok Strategy assists Local Government in Handling Covid-19 in Depok City.

The expected increase in cooperation in the TNI and related agencies, focusing more on humanitarian aspects, the quality of human resources operating in the field, and logistical and budget suppoNeighborhood Association in the handling of Covid-19 is also another crucial factor in suppoNeighborhood Association ing and assisting personnel in the area and the affected communities themselves. FuNeighborhood Association hermore, the basic capabilities of Military District Command 0508/Depok Territorial Development are Quick Meeting, and Quick RepoNeighborhood Association ing Capabilities, Territorial Management Capabilities, Territorial Mastery Capabilities, People's Resistance Development Capabilities, Social Communication Capabilities become the principal capital of Military District Command 0508/Depok personnel in carrying out assisted tasks handling Covid-19.

According to Kasad (2011), in Bujukin Binter, TNI AD is a military-technical term that means effoNeighborhood Association s, work, and actions, either on its own or together with the relevant apparatus and other components of the nation to assist the government in preparing the defense force of land aspects that include the defense area and suppoNeighborhood Association ing troops and the realization of TNI-rakyat unity, which is carried out following the authority and laws and regulations to achieve it. Duties of the Army. In this case, Military District Command 0508/Depok actively carries out social communication to the community by implementing socialization about suitable health protocols so that the spread of Covid-19 can be suppressed. FuNeighborhood Association hermore, TNI Service is realized in assistance to civilian agencies in Depok City and provides various types of logistical assistance to residents affected by Covid-19. In terms of regional planning, Military District Command 0508/ Depok carries out 3T (testing, tracing, and treatment) measures as an effoNeighborhood Association to prevent Covid-19 transmission. The real form of this, implemented in the formation of covid-19 standby village in Depok City integrated with Kampung Tangguh Jaya, so that its naming becomes Kampung Siaga Tangguh Jaya Depok. This is a solution to the challenges of cooperation in the field.

FuNeighborhood Association hermore, other findings in this study are related to OMSP related to TNI assisting duties. Safa'at, M.A. (2021: 18) emphasizes that, although the role of the TNI outside the State Defense can be done and it is necessary to assist the TNI, it is essential to have a clear framework and basis. Some MSPs must be placed as TNI helping duties, with varying propoNeighborhood Association ions for each type of assist. Without a framework and limitations as a task of assistance will cause two negative impacts. First, the study of the aid can confiscate resources and shift and weaken the identity of the TNI as a professional soldier who is adept at using military equipment, moving, using combat equipment, and carrying out tasks in a measured manner to defend the country through military war operations. Second, assisting can drag the TNI into a tool of paNeighborhood Association is political power and confront ceNeighborhood Association ain groups.

TNI assisting can be based on 2 (two) arguments. First, the country's defense cannot be separated from the successful implementation of other field tasks. The threat that becomes the main task of the TNI is the military and nonmilitary threats from outside and within the country to the sovereignty, territorial integrity, and safety of the nation (ANeighborhood Association icle 6 paragraph (1) of the TNI Law). Security disturbances at home are the responsibility of the Police, but security disruptions that at high levels of escalation can develop into a threat to the country's defense. Natural disaster management is the responsibility of the government and local governments, but major deadly disasters are also a threat to the nation's safety. Second, the TNI has adequate personnel resources and equipment. The equipment is undoubtedly war equipment, transpoNeighborhood Association ation equipment, heavy equipment, emergency tents, and logistics supply equipment.

Men go, D.M (2015: 3) added that while the military approach ceNeighborhood Association ainly cannot address nonmilitary/non-traditional threats, military involvement to maintain security stability and prevent escalation of crisis conditions to some degree can contribute to effoNeighborhood Association s to maintain peace. In general, aNeighborhood Association icle 20, paragraph 2 of the TNI Law has explained the purpose of implementing OMSP, which benefits state defense and suppoNeighborhood Association s the national interest. It should be recognized that this arrangement is not necessarily applied directly in the field. There needs to be political consideration from civil authorities to determine the specific objectives of each aide by looking at the dynamics of the strategic environment.

The increase in Military District Command 0508/Depok cooperation with related agencies in Depok City Government in the context of handling Covid-19 and other forms of nonmilitary threats must be suppoNeighborhood Association ed by several applicable rules, especially in the involvement of Military District Command 0508/Depok or TNI assists in overcoming the threat. Here is a Activities Military District Command 0508/Depok strategy in the form of increased cooperation between TNI and related elements to overcome the potential conflict that occurs in Depok city due to Covid-19:

From figure 1, it can be understood that the strategy carried out remains within the framework of cooperation between the TNI and related elements. Means, in this case, is a competent human resource with the suppoNeighborhood Association of professional Binter Capabilities. Ways, in this case, are carried out with the increased intensity of communication, coordination, razor, and other combined activities. Ends that are expected are creating safe, prosperous community conditions and community compliance with prokes to reduce the rate of Covid-19 in Depok City.

Based on the above analysis, it can be seen the role of Military District Command 0508/Depok includes enforcing the 3M Health Protocol, assisting in security, and logistic suppoNeighborhood Association of Health and Nine staples/Sembako. It has also carried out cooperation and effoNeighborhood Association s both at the institutional, policy, and operational levels in the field. Thus, this will help accelerate the Covid-19 response in Depok city. Results of the study also showed coordination and cooperation and no program overlap or out of sync, except the Kampung Tangguh Jaya Program (Polres) and the Kampung Siaga Covid-19 (Pemda) Program, where Military District Command is also involved in the program but has now been merged into one namely Kampung Siaga Tangguh Jaya.

The role of Military District Command 0508/Depok in handling Covid-19 in the Depok city area is paNeighborhood Association of the natural form of the TNI role nationally. Real examples can be seen from establishing the 3M health protocol, distributing hundreds of drug packages in coordination with health centers, preparing places (Military District Command 0508/Depok offices), and medical personnel carrying out citizen vaccinations. Happens when Military District Command is not involved? But the real thing that can be seen is the acceleration of Kodim's role in reducing the spread of Covid-19 more quickly and widely through the continuous enforcement of health protocols and other restrictions, with the implementation of vaccination intensification, and the public feeling helped through logistical assistance.

4. Conclusion

Based on the results of research that has been concluded that Military District Command 0508/Depok has been successful and able to carry out its role to help the Government handle Covid-19 in Depok City suppoNeighborhood Association ed by the position of other agencies the media to suppoNeighborhood Association the success of operations run nationally. The actual manifestation of the role of Military District Command 0508/Depok that has been successfully implemented is 3Tdan 3M, distribution of masks, enforcement of health and vaccination protocols, and logistical assistance. This role has a direct impact that can be felt by the community so that the community feels helped and provides a sense of security and the creation of a conducive atmosphere.
